I would like to thank our members for continuously bringing in new candidates. A few things to please remember to let them know:

- Application fee is \$25: \$10 upon completion of the application, the remaining \$15 is collected at Initiation. Once completed and the partial fee is collected, give the application to the bartender and make sure she/he issues a receipt for the \$10.
- The Elks year runs April 1 March 31.
- Annual Dues are \$60 (If you are initiated during the year, the dues are pro-rated)
 - Once a date is determined for Investigation/ Initiation a letter will sent to all candidates. Note: we don't hold these every month so there can be a delay from the time we receive the application to the time a letter is sent out (could be a month or more)
 - Remind them to keep their receipt so they may come to the lodge while awaiting Investigation/Initiation
